The Parish Council meeting was held on Wednesday 24th August 2022 at 7.15 pm in the Village Hall.

0594/22 Members present:

0595/22. Apologies for absence:

Councillor Tara Pickles and Bradgate Park Director, James Dymond.

0596/22. Vacancy in Office of Councillor

Councillor Harvey Singh signed the Declaration of Acceptance of Office and the Register of Members' Interests

0597/22. Confirm and sign minutes of the 13th July 2022 meeting:

These were approved and duly signed by the Chair.

0598/22. Declaration of Parish Councillor's personal and/or prejudicial interests on agenda items:

The Chairman represents the Gardening Club on the Village Hall Committee.

The Chairman is a member of the Management Committee at Lingdale Golf Club.

Councillor Tara Pickles represents the Council on the Magazine Committee.

In addition, Councillor Harvey Singh declared a personal interest in item 12 - n of the agenda with regards to an outline planning application for the demolition of 287 Markfield Lane, and the development of up to 150 dwellings, together with open space, landscaping, and drainage infrastructure (All Matters Reserved except Access) and has therefore, recused himself from discussions.

0599/22 Public Participation

17 members of the public were in attendance, many of whom with regards to Item 12 (n) on the agenda for an Outline planning application for the demolition of 287 Markfield Lane, and the development of up to 150 dwellings, together with open space, landscaping, and drainage infrastructure (All Matters Reserved except Access) P/22/1031/2.

The Council **resolved** to bring Item 12 (n) forward on the agenda.

Councillor Harvey Singh joined attendees in the public gallery as a member of the public.

The Chairman opened the discussion by delivering a presentation regarding all the information available to date and guidance (see individual slides in **Appendix One**). NLPC had requested an extension to the consultation period and this had now been extended until 28th September 2022.

The outline plans submitted indicate access would be made available by the demolition of 287 Markfield Lane to create an access route. Alternate representations within the same boundary, show access could also be through demolition of either 211 Markfield Lane and 273 Leicester Road, Field Head, should this outline application be refused.

Comments had already been submitted by Cllr. Snartt, Cllr. Taylor, Cllr. Matthew Lay for Markfield, Stanton Under Bardon and Field Head and Markfield Parish Council.

Councillor Snartt has called the application in for consideration by the Charnwood Borough Council Plans Committee if not recommended for refusal. The Chairman of the Parish Council would also request an opportunity to speak as part of NLPC's response. Cllr. Snartt said previous historic applications on adjacent land had been refused.

Newtown Linford had been mentioned only four times throughout the submitted planning documents and it was clear Markfield had been identified as the service centre for this development.

The Chairman delivered guidance on Material and Non Material Planning Considerations including lack of infrastructure and transport links, impact on community including the primary school, GP surgery, shops and traffic and loss of privacy and daylight etc. It was noted, Mercenfeld Primary School are only just within the permitted sustainable limits.

Highway safety is also a concern and traffic levels were assumed to increase by 103 more traffic movements during morning peak times and 112 more traffic movements during late afternoon/evening peak hours, in the direction of Field Head upon exiting the development. Cllr. Taylor informed the meeting there had already been 34 personal injury accidents recorded in that location and should planning be granted, improvements to the A50 roundabout at Field Head would be required.

The Chairman commented that the traffic survey carried out had been conducted whilst Covid restrictions were still in force and many people were working from home. The survey was also not carried out during weekends.

The Design and Access Statement submitted by Pegasus on behalf of Davidsons Developments, shows a two carriageway access road to the proposed development, with a single footpath on one side and a 0.5m wide verge alongside number 285 Markfield Lane, leaving only 2 metres between the road and the side entry door/garage.

A resident had also calculated the geometry of the access road. They believe an 11.3m width is needed to accommodate the proposed access road within the land of 287 Markfield Lane based on the proposed dimensions of 5.5m road width, 6m curb radii, 2m pavement and 0.5m verge, however, the actual width of the existing land is 10.4m.

Visibility would be poor for motorists exiting the proposed development but removal of trees and bushes would result in a loss of privacy for both houses either side of the access road.

Tree and habitat loss across this area of land and the negative impact on biodiversity and green space is a concern. The Ecological Appraisal prepared on behalf of Davidsons by Brindle and Green, was carried out off season in February and shortly after vegetation clearance, including the felling of mature trees and flailing of hedgerows. Grassland has also been incorrectly described and the report lacks an adequate assessment of the impact of the proposals upon vegetative habitats.

The Chairman advised attendees, that should outline planning permission be granted, Newtown Linford Parish Council must submit a request for Section 106 funding during the statutory consultation period of the planning process, as it will be of vital importance to install equipment to monitor traffic and control speeding within the Parish and upgrade facilities for such a large number of new residents. Residents were encouraged to submit comments now the statutory consultation period is live. Comments can be submitted by email, letter or directly on Planning Explorer by 28th September 2022. All valid comments must be considered by the Planning Authority at CBC.

Resident A commented that light pollution would increase from dwellings, street lights and cars and this would have an impact on wildlife too.

Councillor Tim Porte joined the meeting at 7.45pm

Resident B commented that transport links in the area were already unreliable and believed Leics. Police Safer Roads Team would be objecting to the plans. Resident B had also requested Air Pollution monitors for Markfield Lane, Newtown Linford and Leicester Road, Field Head. The same resident later stated documentation and emails had not been uploaded to the case on Planning Explorer. Cllr. Snartt said he would address this matter.

Resident C asked if HBBC would need to grant access should the proposed plans change to access route via 273 Leicester Road, Field Head.

The Chairman referred back to a recent cross boundary application at Ashby Road, Markfield and explained CBC were the responsible authority for planning permission but HBBC were the responsible authority for granting access to the site. In this case, CBC approved planning permission but HBBC refused access. This application is now subject to an appeal which has been lodged against HBBC's refusal.

Resident D commented that traffic already backs up along Markfield Lane from the A50 roundabout in the mornings and would encourage traffic to turn right out of the proposed access road, onto Markfield Lane and route through Newtown Linford. This would also pose a further danger when turning right with reduced visibility, when traffic is queuing towards the A50.

Resident E stated that as there are already difficulties navigating across the A50 roundabout into Markfield, Anstey would be the preferred service centre, thus further increasing traffic movements through Newtown Linford.

Resident F stated they already have to reverse their vehicle onto their driveway on Markfield Lane and this would be more dangerous to do with increased traffic movements. Resident G agreed and said due to the turning circle onto their driveway, they have to cross the carriageway to swing back in.

Resident H asked if the same analysis would be carried out if the access route was changed to either of the other two possible dwellings at 211 Markfield Lane and 273 Leicester Road.

The Chairman suggested everyone needed to be clear on all the access issues for each possibility and the effects on Markfield Lane and Leicester Road, sustainability being key.

Other residents commented that many neighbours had been approached by developers asking if they wished to sell their homes.

The Chairman asked Councillors if they were in favour or against this development

Resolve: Councillors voted unanimously against this planning application and agreed comments of strong objection, including a request for S106 funding for community benefits, will be prepared and submitted via Planning Explorer by mid-September.

Councillor Singh rejoined the meeting. 12 residents left the meeting, 5 remaining.

0600/22. Police Matters and NHW reports:

PC Greg Moore was in attendance and reported the following crime statistics:

 $1 \times Burglary$ and Arson at chalets on Roecliffe Road on 05/08 – Chalets were entered and culprits returned the next day and set alight to a mattress in a field. No suspects identified.

1 x Criminal Damage at Bradgate Park on 12/08 - Vandals tried to gain access to the burial chamber at the Bradgate Park ruins and caused damage to fencing. No suspects identified.

1 x Criminal Damage at Sandhills Lodge Farm – Vandals broke in and caused damage to trees. No suspects identified.

Police have also been receiving regular reports of anti-social behaviour within Bradgate Park at night. Between 7 and 9 adults have been riding motocross bikes around the park after closing and had been abusive and threatening upon being challenged. PC Moore advised this was difficult to enforce due to Health and Safety regulations not allowing Police Officers to give chase but also, the park cannot be closed due to Public Rights of Way. Police are currently looking at the pattern of events and possible operation to include the Police drone.

Reports had also been received regarding anti-social behaviour in the lay-by on Groby Lane at night and included regular incidents of fly-tipping.

The Chairman asked if speeding operations continued in the Parish. PC Moore advised 12 to 15 sites had been identified for regular speed checks by both marked and covert police vehicles. Data collected is passed onto LCC Highways.

A Councillor informed PC Moore a poster had been displayed on Roecliffe Road identifying two suspicious vehicles, including registration plates. PC Moore will look into this.

Resolve: Noted with thanks.

0601/22. Bradgate Park

Bradgate Park Director, James Dymond, had sent apologies to the meeting.

The Chairman advised a rock dam which had been placed in the River Lin on BPT land, will be removed following concerns raised by a resident and thanked Cllr. Taylor for her assistance with this matter.

0602/22. Newtown Linford Biodiversity

- Newtown Linford Biodiversity representative, Claire Costello, was in attendance to update Councillors on current work (see **Appendix Two**).
- The SHIRE Environment Grant 2021/22 was now complete. £591.00 funds had been received from LCC 12/08/22.
- Councillors considered purchasing equipment for the ongoing maintenance of the wildflower verges on Markfield Lane and Groby Lane, following advice received from BHIB Councils Insurance, to include: 1 x petrol strimmer, strimmer cable, 1ltr 2 stroke oil, 10ltr fuel can, 2 x scythes, scythe sharpening stone and hay rake. Total cost £241.89.

Resolve: Noted with thanks to Newtown Linford Biodiversity and to LCC for the SHIRE Environment Grant. Councillors agreed to purchase the equipment for the ongoing maintenance of the wildflower verges, costing and estimated £241.89. Clerk to action.

cost in the region of £3000. Advice had been sought from Rupert Simms, Senior Ecological Officer in the Planning & Regeneration Service at Charnwood Borough Council.

Comments submitted by Cllr. Taylor had been received by email on 19/07/22 and cascaded to Councillors for information.

0607/22. Bob Bown Memorial Field.

- Appointment of Cllr. Singh to the Bob Bown Memorial Field and Play Park Committee.
- The Clerk had met with a representative from Wicksteed on 25/07/22 regarding possible new equipment for the play park, alternative surfacing to wetpour and issues arising with current equipment following the heatwaves. The Clerk had received some costings for replacement 'carpet' style surfacing but awaits further information and designs. The Clerk advised this new surfacing would come with an 8 year guarantee and is laid over the current wet pour. The price also included a climbing wall to replace part of the old wooden play equipment, which had formed large cracks during the two heatwaves. The cracks could cause finger entrapment and would be likely raised during this years' annual inspection.

Appendix Two - Update from Newtown Linford Biodiversity

Newtown Linford Biodiversity Group - update for N.L.P.C.meeting 24th August 2022

Webpage on the Parish Council website now up and running

Wildlife walks: We've continued with our monthly wildlife walks. Next one: 17th Sept. in Benscliffe Wood.

Local visits: We visited Nigel Blythe's wildflower meadow and pond in June, and Benscliffe Hay Cottage in July. It's encouraging to visit areas in the parish managed with biodiversity in mind.

Conservation work has continued with:

Himalayan Balsam-pulling

We've held several sessions over the summer at various locations in the parish, including alongside the public footpath in Ulverscroft. We always get permission from the landowners. We were delighted that our efforts last year at several sites were rewarded by significantly reduced regrowth, proving it to be a worthwhile exercise. We'll be carrying on with this next year.

Markfield Lane and Groby Lane verges – County Council's Leicestershire Urban Verge Wildlife Project

In September, we'll be carrying out conservation work on the wildlife sections of these two verges. This involves cutting the grass, waiting a few days for the wildflower seeds to drop on to the ground, and then raking up the resulting hay (or arisings); wildflowers flourish in soil that's poor in nutrients which is why the arisings are cleared away.

A selection of tools (scythes/strimmer/hay rake) owned by the Parish Council would be an extremely useful resource, enabling N.L. Biodiversity Group volunteers to be covered by P.C.'s insurance when undertaking conservation work.

All Saints Churchyard

The efforts of last year in tackling the thistles threatening to take over the wildflower corner also paid off as there were far fewer this year. Interesting to see how the variety and diversity of the wild plants changes from one year to the next. We'd like to encourage more people in the community to get involved in this, and in other practical conservation work.

Shire Environment Grant

We were delighted that at least three of the bird boxes have already been used this year. In each case, adult blue tits were seen going in and out of the box, feeding the chicks. We'll be asking local residents to help in monitoring the use of some of the bird, and other wildlife, boxes.

In June, the last of the wildlife boxes purchased by the Parish Council as a result of the successful Shire Environment Grant application were installed. For this the P.C. and N-L Biodiversity had invaluable assistance from Peter Williams of Leicestershire and Rutland

Ornithological Society, and Jools Partridge of the Leicestershire and Rutland Bat Group. We are very grateful to them for this help.

Bat boxes were sited at all three areas maintained by the Parish Council – cemetery, Bob Bown Field and churchyard; a Barn Owl box was installed in a hedgerow tree at the cemetery (which proved to be a tricky procedure), and a Tawny Owl box on one of the trees in the woodland at Bob Bown Field.

One of our members has bat recording equipment and we will try and monitor the future occupancy of the bat boxes (though we won't be able to have a look inside the boxes ourselves - need to be registered for this)

Field Head planning application: Members of the group have many concerns about the potential loss of this green area and its accompanying biodiversity, and are planning to send in comments to Charnwood Borough Council.

County Councillor Report – August 2022

Cost of Living Crisis

We are all suffering from the cost-of-living crisis, and this impacts our daily lives. I just wanted to share some details about the support that is available locally through Leicestershire County Council covering:

- Public Health
- Environment & Transport
- Adults & Communities
- Children & Families.

At a partnership level across Leicester, Leicestershire and Rutland (LLR) a 'social welfare cell' has been established under the Local Resilience Forum. The Group is chaired by Leicester Cathedral and draws membership from across LLR. The welfare cell seeks to maximise impact by adding value and supporting the work of partner/constituent agencies. Key areas of focus within the Group's Action Plan are understanding the impact of crisis through data and analysis and supporting key organisations and partners to:

- Build financial capabilities through financial literacy and education
- Increase access to appropriate financial services and affordable credit
- Increase access to money and debt advice.

Green Living Leicestershire

This scheme will fund help for Leicestershire residents go green, reduce costs and tackle climate change. Some homeowners in Leicestershire will be eligible for efficiency improvements which will reduce energy costs as well as making households warmer and greener.

As part of the new 'Green Living Leicestershire' programme, eligible county residents will benefit from fully funded home improvements including loft and wall insulation, solar panels, heat pumps and new efficient windows and doors.

'Green Living Leicestershire' is funded by £3.6 million provided by the Department for Business, Energy and Industrial Strategy, and administered through the Midlands Net Zero Hub (<u>https://www.midlandsnetzerohub.co.uk/</u>)

The eligibility criteria include households with an income of £30,000 or less per year or in receipt of means-tested benefits, and an Energy Performance Certificate (EPC) rating of D, E, F or G. It will prioritise supporting low-income households heated by mains gas, those off the gas grid, and those at high risk of fuel poverty.

This includes investing £100 million over the last five years to create an extra 5,000 school places, including six new schools.

Over £15 million has also been invested in new residential accommodation, supporting older people those with learning disabilities and those living with mental health conditions.

Other achievements include the creation of the £3 million Snibston Colliery Park, expanding green space across the county, the rollout of superfast broadband to 75,000 houses, hundreds supported into skills and employment and the advancement of the East Midlands freeport.

Census - New census data shows Leicestershire growing, with new population figures available by sex and age group. The overall population of Leicestershire has risen from 650,489 in the 2011 national census to 712,300 in the 2021 census (rounded to the nearest 100).

This is broken down by sex, with 351,700 men (49.4 per cent of the population) and 360,600 women (50.6 per cent of the population) living in the county.

The number of households in the county has risen by 11% from 267,434 in the 2011 census to 296,400 in the 2021 census (rounded to the nearest 100).

Appendix Four - Report by Borough Councillor, David Snartt

Local Plan Update.

The Inspectors conducting the examination of the Charnwood Local Plan have provided a further update. As you will recall from my previous reports, the hearings were paused in July as the Inspectors wanted interested parties to have an opportunity to comment on the evidence which underpins the

apportionment of Leicester's unmet housing need. The consultation, which is a focussed piece of work and aimed at those involved in the examination process, is now underway. The Inspectors have now confirmed examination hearings will resume in October and sessions will take place on October 25th and 26th to consider housing and employment needs.

The Inspectors say there will be a 'reflective pause' to enable them to reach a position about the apportionment of the unmet need for both housing and employment and for the Council to respond as necessary, enabling any implications for the plan to be properly considered. Charnwood Borough Council has challenged the need for this further pause, as the Council feel it is in the best interests of the Borough to ensure the Local Plan is adopted as soon as possible. However, the Council respects the Inspectors' decision and process.

Dates for future hearings after the October sessions have yet to be confirmed by the Inspectors. The Inspectors are responsible for the examination process, including setting the timetable. The Council are awaiting further information before they can properly assess what this means for the timetable to adopting the Local Plan. More information is available on the Council's website, Local Plan 2021-37 In my view, as I have previously stated, this is particularly bad news for our local area. Any delay in adopting the Local Plan will see more piecemeal development coming forward, because Charnwood Borough Council cannot demonstrate a five year housing land supply. That said, I still believe certain modifications to the Local Plan need to be in place, in line with my submissions to the Inspectors during the consultation process. These reflected on the large number of dwellings allocated to Anstey and the large development close to Woodthorpe that encroaches into the Woodhouse Parish. In my opinion, both these proposals will have serious consequences for the surrounding infrastructure and the wellbeing of local residents.

Financial Help.

After receiving a telephone call from a resident, there seemed to be some confusion about current Government grants that have been announced. Therefore, I thought it would be appropriate to give the details I have received from Charnwood Borough Council.

The Government is providing a range of extra support which will be paid to eligible individuals automatically, to help with the rising cost of living and the pressure that puts on household budgets. £650, cost of living payment for most people on means tested benefits, payable in two instalments, the first paid in July (£326) and the second will be paid in the autumn (£324).

Households in England, Wales and Scotland will receive £400 discount to help with the cost of their energy bill from October onwards.

£300, pensioner cost of living payments that will be paid with the winter fuel payments to all pensioner households across the UK.

£150, disability cost of living payments for those on an eligible UK disability benefit, paid in September. More information can be found on the Government website, Cost of Living Payment. I understand further Government announcements will be made on future help with the rising cost of living.

The Charnwood Sports Awards.

The Charnwood Sports Awards are back for 2022 and residents are being encouraged to enter their nominations. The awards run by Charnwood Borough Council, will celebrate the sporting achievements of individuals and clubs as well as the dedication of volunteers. They will also highlight schools and workplaces making a difference to health and wellbeing in the Borough. It is the first time the sport awards have taken place in three years due to the Covid-19 pandemic.

This year's ceremony will take place on Monday 5th December 2022. The deadline for nominations is midnight on Friday 7th October 2022. Nominations for the awards are now open and include in the nine categories: Lets get moving schools award: Junior sportsperson of the year: Senior sportsperson of the
